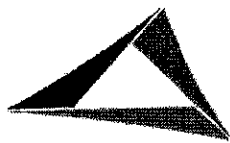

RE: **Educational Neglect Petition**

- To my knowledge there is no outside agency counseling in place at this time.
- School followed procedure to resolve problem on internal level but not successful with student and parent.
- John is eleven years old and in the fifth grade at Keicher Elementary School.
- To date has been absent 6 unexcused days, 3 excused days, and had 31 tardies to school.

- Referral to ISD September 24, 2008
- Previous referral to ISD none
- Letter to parent none
- Verbal contact with parent September 26, 2008 with mother
- Attendance problem continues to be an issue.

John Doe is 11 years old and in the fifth-grade at Keicher Elementary School. He has a history of poor school attendance beginning in kindergarten. I contacted his mother, Ms. Doe, as a result of receiving a request for services from John's school. She indicated that he has ADHD and that is why he is always late for school. She indicated that his medication needs to be in him a certain amount of time before he goes to school. I recommend it to her that she get him up earlier and that she gives him his medicine earlier in order for him to be ready to be at school on time every day. I explained to her the seriousness of his continuous tardies to school.

It appears that Mr. & Ms. Doe have no intentions of having their son, John, at school every day and on time. I am requesting the support of the court in charging Harry and Lisa Doe with Educational Neglect.

Should it be necessary to subpoena school personnel, I would recommend that be directed to building Principal, John Brock.
